New report types: Power BI reports

We have successfully piloted Power BI reports for building cleaning inspection data which allows members to access interactive online reports. This is part of our commitment to reduce printed materials, which members have requested from the consultation, and to replace this with more interactive on-line reports.

Draft Power BI reports for the main benchmarking services have been consulted at the working groups and will be fully developed this year. These will supplement the current report set which will be predominantly produced in PDF. Power BI reports are also being developed for the other inspection apps: LAMS, PIMS and MIST.

One-2-one online support

We are now offering 1-2-1 online data support sessions. This is where a subject matter expert will join you on MS Teams and help complete your data template with you in real time. These sessions are useful if you are mid-way through populating your templates and need some additional guidance, or are only just starting and need support in the initial stages. New climate change module!

APSE have launched a new module to enable local authorities to accurately monitor how emissions are changing over time and consider them in the context of the local government sector. The data templates have now been created and we have received 80 registrations to the new module. The timeline for the data collection for this coming year is as follows:

Sport England

Since 2022, APSE have been working with Sport England to reduce data input times for benchmarking leisure centres and provide a level of synergy between the APSE and Sport England Moving Communities data systems. We have now strengthened this collaboration for 2024 to now include financial data in addition to participation, facility usage, and facility management data. To expedite the process for APSE performance networks members, we have created an agreement which allows you to authorise Moving Communities to release this leisure centre data directly to APSE, therefore eliminating the need to input this data in the annual data collection templates.

Emma Bernstein, Strategic Projects Lead at Sport England, said: ***"The collaboration with APSE is an important milestone in supporting a journey of performance monitoring and continuous improvement across the public leisure sector. The work that we can do together will drive quality and increase confidence and we are thrilled to work in partnership to minimise duplication across the sector. It will help and support facilities to demonstrate the positive impact they have on their local communities."***

Power Data Associates (PDA)

Since 22/23 APSE has been collaborating with PDA to reduce data input times for benchmarking streetlighting and provide a level of synergy between the APSE and the PDA data systems. There is an opportunity for APSE performance networks members who use PDA for their lighting stock and energy consumption to opt in to collaborate with PDA to support with the completion of the lighting benchmarking data.


