Seminar Objectives

About the Seminar

Bereavement Services is a high-profile council service which, as well as meeting the needs of the bereaved, is under increasing pressure to become commercially self-sustaining whilst ensuring value for money.

The service area is also facing changing cultural and physical constraints and requirements. As well as facing competing land-use demands, what land cemeteries do occupy is expected to be managed in a way which conserves and preserves historical and cultural assets as well as providing increased opportunities for biodiversity.

More recently the service has played a central role in dealing with the impact of the current pandemic – being referred to as the 4th emergency service by many.

Whilst these challenges have to be met, the heart of the service is still to ensure it considers its customers' needs at the most vulnerable time in their lives.

In a time of austerity, local authorities continue to find their budgets shrinking and, as such, managers and staff alike are having to look for ways to compensate against these losses, either through service efficiencies, generating new sources of income, or innovative service delivery methodologies such as partnership working.

Service delivery is, therefore, having to change. APSE recognises this need and, through the provision of this seminar and its wider networking services, APSE can help elected members, managers and officers hear examples of how these changes can be brought about.

Therefore, the aim of the seminar is to highlight best practice and innovation, which, together, will prove invaluable to the development of future Bereavement Services.

Therefore, this seminar is a **MUST ATTEND EVENT** for those officers and members who want to look at new ways of understanding and coping with cemetery and crematoria issues, whether these be financial, environmental, technological or social.

Speakers will include:

- **PROFESSOR HILARY GRAINGER** OBE, PhD, FRSA, PFHEA, Professor Emerita of Architectural History at University of the Arts London; Honorary Professor in the Department of Theology and Religion at Durham University and Chair of the Cremation Society. Professor Grainger the leading authority on architecture of British crematoria will be speaking on: the architecture and cultural significance of crematoria and considering the architectural challenges presented by crematoria and what these, often contested, buildings reveal about our complex and changing attitudes to death and funeral rituals.
- **DR IAN DUNGAVELL**, FSA AICCM, architectural historian and chief executive of Highgate Cemetery who will be outlining a new 25-year masterplan for the site, which will secure its future and ensure it remains a historic, and sustainable, 21st century cemetery. The plan will transform the cemetery into a place fit for the social, historical, cultural and environmental needs of the 21st century.
- **HOWARD PICKARD,** Managing Director at LBBC Group, who will be updating delegates on the progress of the Resomation or water cremation process, and how it can help Bereavement Services Managers to considerably reduce their carbon emissions, critical to achieving local authority climate change declaration targets.
- **JULIE GREAVES,** Head of Sustainability at Hertfordshire Council, will be looking at why the lack of joined up planning for cemeteries is a problem, the potential options for burial and cremation disposals and also consider how we can better plan for future municipal cemeteries.
- **DALE ROWBOTHAM,** Bereavement Services Manager at Stockton-on-Tees will be outlining the work which has made his service receive APSE's Best Service of the Year Cemeteries and Crematoria 2021 award.
- **LISA PARKES,** Cemeteries and Crematorium Manager from Wirral Council will be outlining how her service has moved from being a paper-based service, to a more digitally focused service, and how this has reaped benefits for staff, partners and the public alike.
- **MARCUS VICKERS,** Operations Manager at Middlesbrough Council Bereavement Services will detail how his service has implemented a wide range of cross –cutting improvements which have brought significant benefits to both staff and customers alike.
