#### **Getting there by rail:**


The easiest way to travel by Matlock is by train via the line from Derby. County Hall is a 10 minute walk from the station.

### Getting there by road:

If you are heading to John Hadfield House please take the bypass (past the Sainsbury's superstore) and continue straight on through both sets of traffic lights to pick up the A6 again. For County Hall and Chatsworth Hall please continue straight on at the new island for Matlock town centre.

If you are travelling from the south on the A6 you are no longer able to come across the bridge into Crown Square in Matlock. You will need to take the bypass to the new roundabout the other side of town and take the second exit to approach Crown Square from the north - or take the first exit off the roundabout to continue north on the A6 toward Darley Dale.

A limited number of car parking spaces are available in the County Hall Car Park but there is limited availability and they will be allocated on a first come first served basis.

The seminar is a working event designed to explore the challenges and opportunities of bringing back into use former industrial land/reclaimed land for renewable energy and regeneration projects linked to decentralised energy benefits.
