1. Welcome

Cllr Norman Hampshire, Chair of the APSE Scotland Parks, Grounds & Street services group thanked all for attending the meeting in Hamilton Town House.

The minutes were noted as a true and correct record of the meeting.

4. Matters Arising

It was noted that there was no matters arising from the minutes of the meeting on 27 November 2013.

5. Allotments: The Fife Model – Peter Duncan, Fife Council

Jan Kennedy from APSE provided a short update of why allotments are on the agenda. Peter Duncan's presentation outlined his role as an Allotment Officer where he assists in creating and supporting groups, manages existing plots/sites, identifies and forms new sites and provides horticultural advice. He also provide the group with an update on Fife's existing plots (before and after – 22 FC managed, 4 FC leased and 5 independent sites) through a series of photographs, explained how the Council cleared them up and increased the supply of growing space, reduced waiting lists, improved facilities and generally improved health and wellbeing in Fife.

A group discussion followed with regards to the Community Empowerment (Scotland) Bill and how this could potentially impact on local authority allotments.

6. Delivering Operational Efficiency through Workforce Modernisation – Wallace Turpie, North Ayrshire Council

Wallace Turpie from North Ayrshire Council (NAC) explained how NAC delivered operational efficiency through the modernisation of their Streetscene workforce. They achieved this through a meaningful consultation process that meant modernising role profiles, changing work patterns, offering new training opportunities and career routes, and putting employees through a re-application process for the new roles. To achieve their aims, NAC had to improve employee engagement and communication and provide visible leadership. They achieved a more skilled, flexible workforce, better outcomes for customers, reduced sickness absence while delivering £1.68m in efficiency savings and improving relations with employees.
