1. Introduction & Welcome

Andrew Kennedy, secretary of the Soft FM group welcomed everyone to Chatelherault Country Park and thanked all for attending the meeting.

2. Attendance & Apologies

3. Minutes of previous meeting held on 18 September 2013

The minutes from the previous meeting held on 18 September 2013 were agreed to be a true and accurate record of the meeting.

4. Matters arising

It was agreed that the comments collected from the soft fm issues "speed dating" discussions would be re-issued to all (see appendix 1 attached).

5. Renfrewshire Council: Whole school approach to recycling

Gordon McNeil, Site Services Manager, Renfrewshire Council provided the group with a very interesting and informative presentation on "Practical implications of waste recycling for schools and food waste for catering services".

Gordon began his presentation by briefly outlining the changes to the legislation which all local authorities were now working towards as well as highlighting what types of dry recyclates and food waste schools would now be required to collect separately.

The presentation also included some of the implications of these new regulations on the school cleaning and janitorial staff including the frequency of collections, collections of separate bags/ containers and the storage capacity for the recycling bins.

The group were also informed of the Renfrewshire school pilot and the results gathered from this before highlighting some of the disposal costs and infrastructure costs. As well as informing the group that some of the Zero Waste Scotland funding which the Council received was used to put waste advisors into schools.

Finally Gordon outlined the delivery model and outcomes from Renfrewshire Council's whole school approach to recycling which included recycling champions in all schools, educating pupils, using the weighing of the waste as part of the curriculum and catering/ teaching staff support for the changes. As well as

highlighting some of the next steps which included rolling out the programme and providing a communication strategy for each school.

6. Scottish Government Free School Meals from January 2015 (p1 – p3 pupils)

Andrew Kennedy, Head of Facilities Management, Easy Ayrshire Council provided the group with a review of the previous p1-p3 pilot for free school meals. His presentation included details of the increase in school meal uptake from the pilot and that there were no unexpected impacts or barriers.

Andrew went on to speak about the outcomes and results which included:-

- Good planning and good co-ordination beforehand
- Teachers, and catering staff very positive
- Popular service with parents
- Significantly increased uptake spiked at 80% stabilised at 70% (1,000 more children)
- Operated a family service to create a social ambience
- Identified need for assistance in the dining room.
- Small children need good organisation, support, encouragement
- Small number of schools did not have the space or capacity
- The trial improved the viability of the service and maintained employment where school roles were declining

Following the presentation there was a group discussion on the new announcement for 2015. It was highlighted that although the announcement would come into force in January 2015 there would need to be a number of provisions in place by August 2014.

Also it was noted that it could mean an extra 10 meals in one school and 150 in another as it would be dependent on current uptake. Another key point to note was that some Councils had no capacity for this currently and that there would be a need to think about procurement regulations.

Another key area discussed during the group meeting was the issue of the length of time for school lunches to be provided, this ranges between 30 – 45 minutes in some schools.

Running costs and capital costs were another important area, as well as the communication and buy in of head teachers and directors of education.

It was agreed that as well as the presentation (which would be made available on the APSE website), APSE would also provide the link to the full evaluation of the original pilot. Full pilot evaluation can be found here

7. Monitoring performance within janitorial services

Moira Mason, FM Performance Manager, City of Edinburgh Council provided some background to janitorial services and why it was becoming more relevant for Soft FM services to look at the performance of this service, due to janitorial services being within many Councils FM remit etc.

A discussion then followed on the various roles and responsibilities within janitorial services and it was highlighted that these could be extremely wide and varied. During the discussion it was also noted that a number of local authorities had completed reviews with regards to janitorial services.

It was agreed that a working group would be set up to look at producing a questionnaire/ matrix for Soft FM contacts to complete in order for APSE and the group to gather a better picture of janitorial services within local authorities. Volunteers for the group included:-
