Seminar objectives

In January 2017, The Welsh Government released the White Paper 'Reforming Local Government: Resilient and Renewed'. This paper charted a new path for Welsh Local Government, one that sought local authorities to collaborate and share services. There were hints of statutory collaboration, regional working and areas boards, but with many questions left unanswered on governance of the new structures and an over-emphasis on the benefit of yet untested shared services within the Health Service.

This seminar looks at some of those local authorities who have taken the initiative themselves to seek mutual benefits and savings through collaboration. APSE research found little merit and few savings from in merging councils, but we do find that opportunities exist for Local authorities to raise revenue and spread costs through trading and charging and where advantageous, collaboration and sharing of staff and assets to deliver front-line services.

Each speaker will provide a case study on their reasons for collaboration, the legal form that took and the cultural and financial obstacles that had to be overcome to realise the goal.

APSE hope all Welsh Authorities take the opportunity of attending to explore what collaboration might offer them through the first-hand accounts of those who have found successful solutions.
