






The final piece of the jigsaw: Elected members, everyday politics and local democracy in Scotland

This research seeks to contribute to on-going debates in Scotland over the future of elected members in local democratic politics. It focuses on the problems surrounding the current role of the elected member by examining their everyday practices, before offering six recommendations that strive to show how we can successfully reinvest in this important role. Through this research, we show that elected members and their everyday practices should be seen as the 'final piece of the jigsaw' in Scottish local democratic politics.



APSE Scotland Scottish Toolkit for Solar PV

Discussions with APSE Scotland have determined that what is required is a practical toolkit: a step by step breakdown of the process with options for each local authority and the different paths available.

The purpose of the toolkit is not to give definitive guidance to each local authority on every step but to provide a strategic overview of that path. The intention is that this is then used to inform and assist local authority personnel to develop their own strategies for development projects and do so in the knowledge that these are deliverable.


