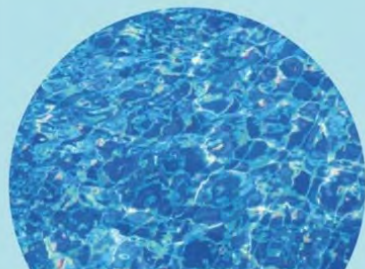

The policy issue of retail domestic energy in the UK has taken on a very high media profile over the past few years. A number of separate, but related issues have coalesced into making domestic energy bills a front line political agenda item. The legislative needs of agreed CO2 emission reductions, when combined with domestic housing stock conditions has meant keeping homes warm is not a cheap option. Yet whilst domestic energy usage has fallen by over 6% average dual fuel domestic energy bills have risen by over 70% in under a decade. 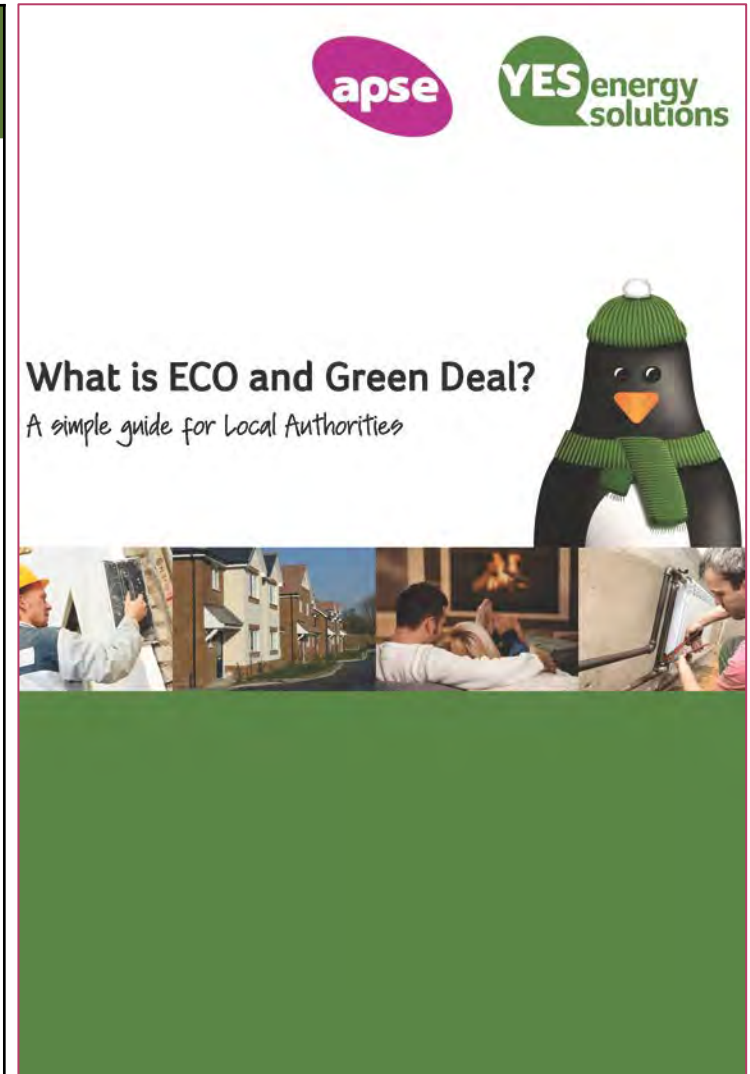

Work Study - Time & Motion
