Taking a commercial approach

Local Government within Scotland is facing a number of challenges. Resources are not unlimited and yet demand for local council services is ever increasing. Reliance on ever decreasing central funding for local councils means stark choices; cut services or find other ways to meet these ongoing challenges. That is why APSE Scotland commissioned this guide for our member local councils to explore the dynamics of commercialisation in local government.

By commercialisation we are talking about those activities that local councils can provide at a charge in order to generate additional income. It makes clear that local councils are not at liberty to charge for those services that they ought to provide on a statutory basis, and nor would we want that to be the case. However, local councils in Scotland can add value to services that they already provide and are more than capable of entering into markets; both new and existing, to bring added value to citizens and to local economies.

Recent example RSC0976 – Method statements A member authority is looking for information as to whether other councils would be willing to share method statements / safe systems of working for the following tasks please: needle searching void / abandoned properties, removing and dumping all contents from houses and pressure washing (capturing effluent to prevent waste from dispersing into a water course)

Performance Networks



- Year 20 Submission deadlines Final date for return of data collection template or for updates and amendments: Refuse Collection – October 30th 2018
- Markets pilot APSE have been working with NABMA over a benchmarking pilot for markets during 2017 which has been really successful. This service is being rolled out fully in 2018 and is available free of charge to those authorities who are members for 'all services'.
- Corporate Services module We have issued a Register of Interest to corporate contacts of performance networks to gauge the level of interest in introducing a new benchmarking module on Corporate Services. We have a group of 10 authorities to pilot this during 2018 but if anyone else would like to join, please contact the APSE office.

Performance Networks

 Updated web portal - The web portal is being updated which will include individual log-ins rather than authority-wide log-ins. This will enable more reports and analysis to be uploaded onto the web with customised information such as forthcoming deadlines and dates for benchmarking meetings relevant to that particular service area. This is currently being piloted and will be rolled out during spring.


 New database - APSE continues to work with CAMMS to develop a new database for performance networks to make it easier to report and analyse data and to build a platform for future web-enabled services.
