About the Seminar

Bereavement Services is a high-profile council service which, as well as meeting the needs of the bereaved, is under increasing pressure to become commercially self-sustaining and delivering value for money.

The service area is also facing changing cultural and physical requirements.

Increasing land-use demands are affecting the availability of land for burials and the land cemeteries do occupy, is increasingly expected to be managed in a way which conserves and preserves historical and cultural assets as well as providing increased opportunities for biodiversity.

Whilst these challenges have to be met, the heart of the service is still to ensure it considers its customers' needs at the most vulnerable time in their lives by providing respectful and affordable services

However, local authorities continue to find their budgets shrinking and, as such, managers and staff alike are having to look for ways to compensate against these losses, either through service efficiencies, generating new sources of income, or innovative service delivery methodologies such as partnership working. Added to these requirements is the relatively new task of ensuring services operate in an environmentally sustainable manner to meet climate change targets. Therefore, the challenges for Bereavement Services Managers are growing, and the need to be aware of the latest technology, efficiencies and innovations is now paramount.

APSE recognises this need and, through the provision of this seminar and its wider networking services, APSE can help elected members, managers and officers hear examples of how these changes can be brought about by highlighting best practice and innovation, which, together, will prove invaluable to the development of future Bereavement Services.
