Background

Westmorland and Furness and Cumberland became new unitary authorities on 01 April 2023

The Cumbria (Structural Changes) Order 2022

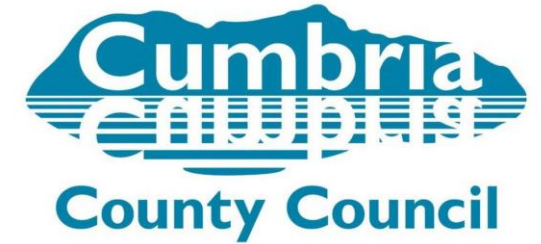
The scope of the Local Government Reorganisation (LGR) programme was to replace the six District, City and Borough Councils (Carlisle City, Copeland District, Allerdale Borough, Barrow-in-Furness Borough, Eden District and South Lakeland District Councils) and Cumbria County Council with two unitary councils and transfer the Cumbria Fire and Rescue Service to the Office of the Police, Fire and Crime Commissioner.

All seven councils contributed to an implementation reserve of £18.9m to fund the programme.

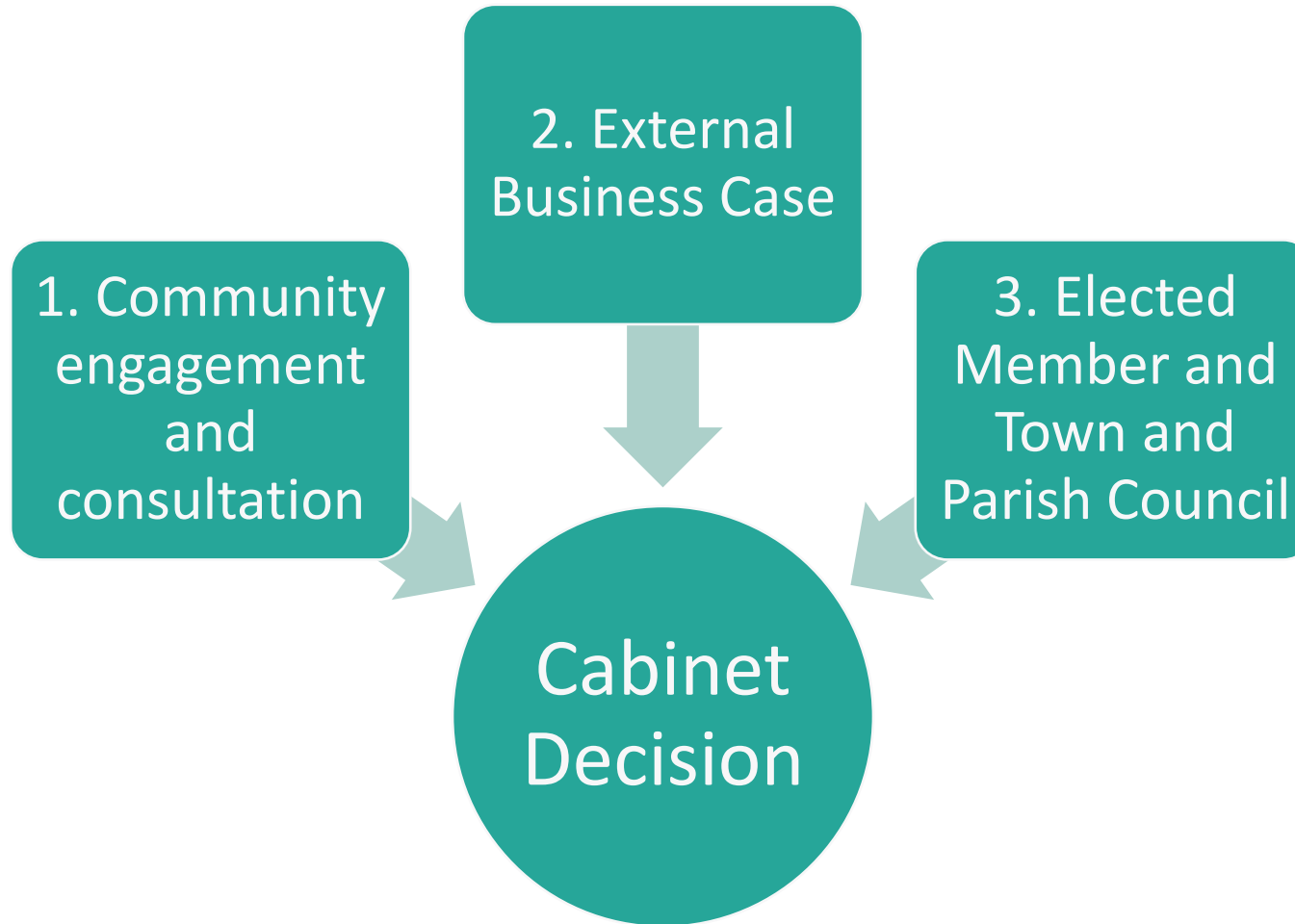

Business Case



Strategic Case	Covering strategic context and ambitions for the proposed changes being considered.
Economic Case	Identifying and assessing the additional public value that could be generated by the proposed changes and quantifying as far as possible the monetary impact of those changes for the public purse.
Commercial Case	Exploring the business implications of the preferred option that emerges from the Economic Case in terms of legal process, HR, estates, ICT and third-party expenditure.
Financial Case	Assessing whether the preferred option is affordable and the source of funding for any upfront investment costs required.
Management Case	Considering the 'achievability' of the preferred option and looking at the actions that would be required to ensure successful delivery in accordance with best practice.
