- District heating to high rise is built in with rent therefore it is an aggregate cost. This now provides approx heating for £10 per week

- Overcladding is a separate scheme to that of the district heating
- Have found a grant which assists owner occupiers to pay for this scheme.

Have been some issues for the Over Cladding with Contractors. One contractor in particular has been working extremely well, has been involved in consultations with residents.

# 6. Ending Homelessness in West Dunbartonshire

Presentation by John Kerr

- 112 organisations involved in this drive to end homelessness in West Dunbartonshire.
- 2000 children under 16 were/had been affected by homelessness.
- Prevention better than the cure (split into 3 strands Long term activity,
  Short term activity and Preventing repeat homelessness)

- Undertook a large media campaign to raise awareness and combat the stigma attached to homelessness.
- 40% reduction in terms of homeless applications and a 47% reduction in the number of presentations from young people.
- Council has also had a 22% increase in tenancy sustainment rates.
- Number of new initiatives and policies helping to reduce homelessness in West Dunbartonshire.
