






Q3. Which of the following services, if any, has your local authority had to cancel or close since 2010?










Q10. From what you know, how fair do you think the new fair funding formula is to councils like yours?












Q12. As far as you know, has the Home Office used hotels, hostels, or other accommodation in your local authority area to house asylum seekers or migrants?




Q13. How well would you say this has been managed in your local authority area?






Q15. How well supported do you feel your local authority has been by central government in managing responsibilities linked to asylum or migrant accommodation?






Q15. How well supported do you feel your local authority has been by central government in managing responsibilities linked to asylum or migrant accommodation?






Q14_Summary. How much of an effect - if any - has this had in your area on each of the following? (0 = No effect at all, 10 = A very large effect).






Q17_Summary. Thinking about councillors across local government, how well do you think they live up to each of the following? (0 = Not at all, 10 = Completely).




Q16. Thinking about councillor standards, how satisfied are you with the current rules governing councillor conduct and accountability in local government?









Q17. Do you think that local services have declined or improved in your local area in recent years?










Q20. Please place yourself on the 0-10 scale below with respect to your opinion on spending in your local area.






Q58. Who do you trust the most to make decisions about how services are provided in your local area?






Q59. Who do you trust the most to deliver services to your local area?

















Q92. Overall, how well do you think the situation has been managed in your local area?








Q98. Overall, do you feel that your council has provided enough information to local residents about decisions involving this type of accommodation?






Q99. When you hear about 'economic growth'in your local area, which of the following comes to mind most?

What We've Learned From Councillors

Financial pressures remain real — but outlook has improved over the year

Councillors still voice **serious concern** about long-term sustainability, but fewer now expect a Section 114/S95 notice than last year — a notable shift.

- Despite a decade of cuts, many councils are holding the line on core services.
- Planning and Housing Regeneration committee members are increasingly sceptical about new housing schemes in their area
- Still majority support for housebuilding, environmental measures, and practical climate action
- Councillors continue to report insufficient support from central government, especially on asylum accommodation responsibilities.
- Standards and conduct systems are viewed as functional but not fully effective, signalling appetite for reform.



What We've Learned From the Public

- Rising satisfaction. While the public still recognises long-term pressures, satisfaction scores have increased across multiple services this year a major positive for the sector.
- People more apt to attribute past decline to national funding decisions, not council mismanagement.
- Strong appetite for more local control and investment, reinforcing APSE's commitment to capable, resilient service delivery
- High support for air-quality schemes, neighbourhood improvements, and green transport
- A proportion of the public seek greater information on decisions relating to home office accommodation
- Local government continues to enjoy significantly higher trust than national government.



The Takeaway for APSE Members

- Local government is delivering despite funding pressure and people can see it.
- Fewer councillors expect a Section 114/S95 notice the worst may be behind us
- Public satisfaction is up across key services.
- Residents and councillors trust local delivery far more than national government.
- There is clear public backing for investment, local control, and cleaner, greener places.
- Your work is driving improvement.
 The public mandate is there.
