# RIF – The beginning



- Initial discussion of the Recycling Improvement Fund at a Scottish Government-led Recycling Summit in 2019.
- RIF announced in September 2020 as part of £2 billion Low Carbon Fund,
   within the Programme for Government 2020/21.
- The fund was launched in early 2021 with a call for expression of interest.
- Current RIF Team recruited in late 2021

### RIF – Aim



"accelerate progress towards 2025 waste and recycling targets and Scotland's net-zero carbon commitment, by strengthening and improving local authority recycling infrastructure, resulting in increased consistency of collection, improvements to the quality and quantity of material collected, and wider environmental and carbon benefits

# RIF – Objectives



- 1. Alignment of kerbside recycling services with the revised code of practice
- 2. Strategic projects which prepare Local Authorities for the future
- 3. Introduce/improve collection of problematic/high value materials
- 4. The development of infrastructure projects at a scale which will improve the capture and quality of recyclable materials at collection and treatment level,
- Support innovation
- 6. Action to change the "make, consume and dispose" throwaway culture
- 7. Replication of best practice
- 8. Maximise the value of the funding awards by working with other local authorities and strategic partners


#### The assessment criteria



- Evidence Led uses data and good practice so that project's plans and outcomes are achievable.
- Impact and Transformation increasing recycling and re-use and reducing carbon emissions.
- Strategic and Collaborative projects with neighbouring authorities, private sector companies and the third sector are very welcome – discuss your ideas with us!
- Feasibility it must be deliverable!
- Additionality why the Fund's grant is needed for the project to go ahead.
- Acceptability elected members support + all necessary permissions/permits must be achievable.

#### The story so far


ZERO WASTE SCOTLAND

- 24 projects have been funded (17 LAs)
  - 12 have been implemented
  - The others are being rolled out as we speak
- So far there is the potential for more than 44,314 additional tonnes of recyclate to be collected each year (49,482 tCO<sub>2</sub>e)
- Circa £53.592 million has been awarded so far.
- Circa £16.5 million remaining.....split between years.
- Another round of applications has been received for the May RIF Board
   which we have just finished assessing.

#### The story so far

- Service changes twin-streaming and changing residual frequency - improving material quality & capture.
- Service expansion improving scheme coverage i.e. to rural or inner-city areas.
- Town and city centre bin hubs improvements to increase recycling of dry materials and food waste.
- Improvements to HWRCs new skips for segregating more materials, or compaction to free up space and allow more segregation for recycling.
- On-the-go recycling in local authority parks and open space – recycling of litter in the same streams as kerbside collections.






#### The story so far

- Recycling and reuse of difficult materials such as mattresses.
- MRF Technology to improve sorting ability, such as for plastic film.
- Reuse projects better segregation of reuse and facilities for refurbishment and distribution.
- Bulking / transfer improvements greater segregation to increase material quantity & quality.
- Data technology to gather improved level of information to help target service improvements and increase quantity and quality of recyclables collected.










City Centre bin hubs
