A general lack of confidence in the whole process.



Key areas:

ECO Strands

ECO is divided into four strands. Each strand has a different energy saving target for Energy Companies to meet. This means that there are essentially four pots of funding available to support householders.





CERO

Funding for all householders to implement measures that cut CO₂

CSCO

Funding for householders in the most deprived geographical zones

CSCO Rural

Funding for low income and vulnerable householders in rural communities

HHCRO

Funding to help low income and vulnerable householders reduce their fuel bills. Key areas:
