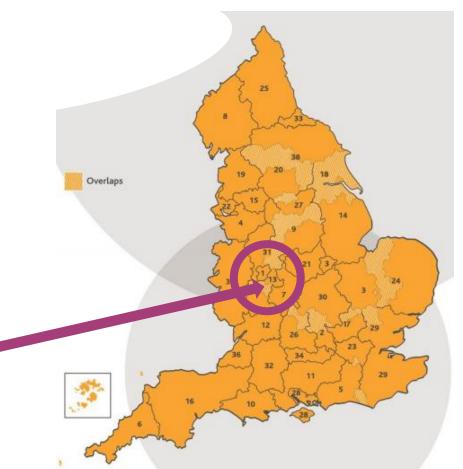




Introduction to LEPs

Established in 2011 Local Enterprise Partnerships (LEPs) are business led public-private partnerships entrusted with public funds and responsibilities to drive inclusive economic growth across England.

GBSLEP is one of 38 LEPs in England, each operating across more than one local authority.

GBSLEP Covers the nine local authority areas of: Birmingham, Solihull, East Staffordshire, Cannock Chase, Lichfield, Tamworth, Redditch, Bromsgrove and Wyre Forest,
