This online seminar is an ideal opportunity for officers, elected members, local authority partners and trade unions to hear how councils across the UK are identifying the impact of Ash Dieback on their greenspaces and tree stocks as well as how the costs of dealing with Ash Dieback are being met.

With so many local authorities planning to increase their tree cover to help mitigate the effect of climate change, the potential loss of up to 95% of the UK's Ash trees could have significant impacts on attempts to increase tree cover and thereby reduce the ability to capture carbon emissions and mitigate against other harmful effects of climate change.

The aim of the seminar is to allow delegates to hear how other local authorities and national organisations are dealing with Ash Dieback. Each of the presenters has been 'hand-picked' for the work they are doing to identify and deal with dead and diseased ash trees as well as looking to the future. The presentations they will deliver, will provide a great deal of useful information for delegates to consider and hopefully implement in their own authorities through the creation of Ash Dieback Plans and practical operational Ash Dieback management, as well as developing strategies which deliver more resilient treescapes in the future.

As such this seminar will help provide guidance and opportunities to listen to and speak with fellow colleagues about how to deal with Ash Dieback, and highlight, how potential solutions are being developed.
