# Local Highway Infrastructure Important to Government

- Local highways identified in the Spending Review 2015 as a priority.
- Additional funding in Autumn Statement 2016
- January we announced details of all funding for 2017/18
- Budget March 2017 will have made further announcements on details of funding for 18/19 onwards




# Local Highways Maintenance Funding

- Between 2016 2021, UK Government is making over £7 billion of capital funding available for local highways maintenance and improving local networks.
- This includes £578 million of this amount has been set aside to **incentivise** local authorities to carry out cost effective improvements and have an up to date asset management strategy.
  - And £250 million through the Pothole Action Fund between 2016 and 2021.
- Additional £1.1 billion National Investment Productivity Fund (NPIF) announced Autumn Statement November 2016. (NEW MONEY)

## Local Roads Money for 17/18

- Needs Element and Potholes Fund by LHA announced 13 January (formula)
- The Incentive Element distribution by LHA is dependent on Self-assessment Band results more on this later
- £75m Challenge Fund 17/18 by competition more on this later
- Safer Roads Fund (£25m in 17/18) for identified A roads
- The new £185m National Productivity Investment Fund (NPIF) for 17/18 by formula



# Challenge Fund for 17/18 (£75m available)

- Competition launched 1 March, Bids by 31 March lighter touch bidding process
- Limit of £5m DfT contribution to each
- One Bid per LHA
- Combined Authorities rank constituent Bids
- No lighting schemes




# Incentive Element - Banding Results






# Challenge Fund for 18/19 onwards

- Bidding process will be launched later this March, likely bid deadline 'early summer'
- Lighter touch bidding process
- Limit of £10m DfT contribution likely
- One Bid per LHA Combined Authorities rank constituent Bids

### National Productivity Investment Fund 18/19 onwards

- Competition announced Budget 8 March
- Emphasis is HOUSING, GROWTH and overcoming barriers to IMPROVING PRODUCTIVITY like congestion
- Bidding process launched later this March, likely bid deadline 'early summer'
- Relatively 'light touch' bidding process in parallel with Challenge Fund 18/19+, and some similarities with Pinch Points
- Limit of £10m DfT contribution likely
- One Bid per LHA Combined Authorities rank constituent Bids
