## Background

---

Scotland Excel Framework for Recyclable and Residual Waste:

*“Handle materials which will be reused or recycled, to treat materials not suitable for those outcomes and to dispose or arrange for disposal of those treated materials”*

Framework effective from July 2014 – 31 May 2017 with an option to extend up to 31 May 2018 subject to satisfactory performance and prevailing market conditions.

35 Service Providers awarded onto framework to ensure capacity, geographical coverage and best value

## Framework Models & Award Options

---

**Model A:** Where a council delivers material direct to a service providers treatment facility. (Direct Award or Mini Competition)

**Model B:** Where material is bulked at an agreed reception point and transported onward to a treatment facility by the service provider. (Mini Competition)

**Model C:** A treatment only option, where councils retain ownership of material post-treatment for market sale.  
(Mini Competition)

## Service Requirements

---

Duration of any call off should be determined by individual councils and their specific requirements.

Pricing at time of call-off for each council will remain fixed for the duration of the call-off. All requests for a price increase will be evaluated by Scotland Excel.

Delivery hours, access to sites and frequencies of deliveries/collections shall be agreed between individual councils and their appointed service provider(s) at point of call off.

# Managing the Framework Agreement

---

Service Providers will provide management information to Scotland Excel on a quarterly basis as a minimum.

Contract performance reviews will be conducted with service providers on a quarterly basis and updates issued.

Councils should communicate directly with Environment Category Team on service providers performance (especially negative) throughout the lifetime of the framework.

Management of day to day operations should be undertaken by councils in line with their own policies and standing orders.

Where poor performance results in the need for councils to increase their level of contract management to an unacceptable threshold, or where operational activity within councils is comprised by poor performance then councils should escalate the issue to the Category Team.

## Key Contacts – Escalating Issues

---

If unable to resolve performance issues with service providers or poor performance, councils should at as early an opportunity as possible, escalate the issue to the Scotland Excel Environment Category Team.
