




November 2015, all licence holders duration snap shot








Licensed issued May 15 to May 16




Typical Company Structure


Overall compliance %


% Compliance 2015 vs 2016







Findings Overview %










Old Route vs New SAP Route







Good Practice

- 1. Yes. Blue (General) Red (Transit) White (Enclosure)- Orange (Waste Transit). Good working practice to separate colours for general/enclosure build & waste transit.
- 2. Air monitoring certs for van available on site for inspection
- 3. Minor amendments by supervisor, major must be authorised by contractors manager. Section of SOP major and minor changes defined with examples.
- 4. There was a Company notice board outside of the enclosure with the Company Certification and other details on it giving a good impression.
- 5. Standard procedures referenced in POW state page number and procedure number Good practice makes it easier for supervisor on site. Procedures have index that is easy to navigate
- 6. Instructions for the use of Propane also displayed with gas bottle in DCU.





Good Practice

- 7. Site diary on iPad and up to date, Excellent system as all checks need to be supported with date stamped photographs
- 8. Smoke test carried out at time of audit, site supervisor and operative who carried out smoke test sign certificate, ACAD auditor signed on this occasion all paperwork and photographs are scanned and sent immediately to head office, Good practice
- 9. Also a daily point of work risk assessment. It was good to see a daily point of work risk assessment carried out.
- 10. The Site Supervisor enters all actions in site diary, regular telephone communication with Contracts Manager. Meetings are held periodically at offices where best practice/lessons learned are discussed.
- 11. Designated emergency exit leads to clearly signed contaminated muster point.
- 12. Waste bags fitted externally to improve air flow and reduce the possibility of slips and trips in airlock.
