- Internal agreement of collaboration,
- Set up in 2001,
- Comprises 8 x WCAs, WDA and UA,
- Dedicated SWP Manager.
- Informal not a legal entity,
- Retain sovereignty,
- Dedicated groups;
 - Staffs Waste Officers Group,
 - Communication and Recycling Officers Group,
 - Staffordshire Sustainability Board.





SWP




- AWC kerbside services;
 - In-house and outsourced,
 - Dual stream fibre separate,
 - Food waste at NuLBC,
- 2 x ERFs for residual waste treatment,
- Numerous reviews / major service changes: low collection and disposal costs.



Strategy

- Legal requirement in two tier system,
- Last full strategy; 2007,
- Main aim of 55% recycling rate target,
- Refreshed in 2013,
- Main aim of Zero waste to landfill,
- Term ended in 2020,
- Mini interim strategy document covering 2020 -2025.





Future

- New joint resource and waste strategy from 2025,
- Food waste collection service introduction from 2026,
- Decarbonisation of fleet and depots by 2030,



- Implications of DRS and EPR on collection composition and tonnages,
- Concerns of financial impact of Emissions Trading Scheme.





JR&WS

- Rethinking waste as a resource,
- Retain former targets,
- Main aim to reduce residual waste,
- Focus on environmental sustainability,
- Modelling existing and new services;
 - Food waste
 - \circ 3 / 4 weekly residual
- Implementation plans;
 - o Communications plans
 - $\,\circ\,$ Individual LA actions plans
- SEA screened out.



Composition Analysis

• Detailed study in 2019;

- \odot 3 times in a year,
- $\,\circ\,$ 3 main demographics per WCA,
- $\,\circ\,$ Kerbside collection of residual only,
- $\,\circ\,$ Shows high food levels, contamination etc.

• Out of date? Post Covid update;

- \circ Summer 2024,
- Changes to consumer habits,
- \circ One off sampling,
- \circ Demographically based methodology,
- Include residual waste at HWRCs and dry recycling kerbside collections.





Timeline

- Draft to Board then Cabinets in late 2024,
- Public consultation in early 2025,
- Full adaption of documentation and publically issued by end of summer 2025.



Resident version;

- 'Together' approach,
- Shorter,
- Less technical,
- More engaging,
- Interactive?





Food waste





- NuLBC already collect,
- New burden funding apprehensions,
- All go together / similar date,
- Shared communications for service commencement,
- 2023; Treatment contract framework with 4 providers,
- Commenced soft market testing for procurement of caddies and vehicles,
- Concerns over lead times, costs and storage.



Decarbonisation

- New project for in-house services,
- Current Euro 6 diesel or HVO,
- Electric fleet and infrastructure consideration,
- Includes all waste fleet and street cleansing vehicles,
- Hydrogen alternative?
- Additional depot modifications;
 - \circ Rain water harvesting,
 - $\,\circ\,$ Solar panels etc.





DRS, EPR and ETS



- Composition and tonnage consideration on service delivery,
- Two tier funding model implications,
- Lack of clear and detailed information / confirmed dates,
- Concerns on budgetary pressures,
- Future proofing.
