The Scottish Government National Transport Strategy

"A transport system fit for the 21st century that provides everyone with integrated, modern, reliable and environmentally efficient transport choices."

- Invested over £8.3 billion in transport since 2007
- Cutting journey times and transport emissions
- Improving quality, accessibility and affordability
- Directly supporting over 12,000 jobs

The Scottish Government Climate change

By 2050 Scotland will have a largely decarbonised transport sector – and we will have made significant progress towards this by 2030.

- The E-Cosse partnership
- Aberdeen Hydrogen project, Cycling Action Plan for Scotland, ...
- Wider infrastructure investment
- Borders Railway opens 2014, 60,000 peak trips off roads each year

The Scottish Government Air Quality

- 30 air quality management areas in Scotland – 26 due to transport
- Scottish Transport Emissions Partnership (STEP)
- Low Emissions Zone Summit event in July

The Scottish Government Buses

- Around 80% of journeys made by public transport
- £¼ billion a year to support the network and concessionary travel
- Plus LA spend on supported services
- Scottish Green Bus Fund £7.7 million since 2010, 94 new low carbon buses
- New Bus Investment Fund £3m/yr Expressions of interest by end May

The Scottish Government Low carbon vehicles

- Technologies battery, hydrogen fuel cell etc – in cars, vans, HGVs & buses
- Sustainable biofuels derived from waste materials - Task Force reporting later this year
- Importance of fleet operators
- Forthcoming EV Roadmap E-cosse

The Scottish Government Eco driving

- Training for safe and fuel efficient driving for HGV and van
- ~£200 per driver, 1 day long, typically saves 10% fuel
- Saving over £2,000 per HGV driver per year and £500 per van driver per year
- Counts towards the Driver Certificate of Professional Competence
- Edinburgh & Falkirk Councils ECOSTARS

The Scottish Government Zero waste

- Designing waste out of the system
- "Re-use", "Remanufacturing" or "Recycling"
- Potentially valuable materials in LA waste collections
- Waste Scotland Regulations step change
- Low base but now driving real change
- Long term financial benefits for Scottish Councils
- 70% recycling target could save LAs ~£187 million by 2025

The Scottish Government Finance & Performance

- 2007-08 to 2012-13 Local government budget up 8.9% compared with 6.4% for SG
- 2011 Spending Review maintained LAs' revenue
- Total SG funding for LAs total funding over £10.3 bn
- Continued council tax freeze
- LAs responsible for own performance benchmarking, improvement, reporting

The Scottish Government Community Planning & SOAs

- COSLA / SG review clear vision for the future, actions to strengthen CP
- Joint National Community Planning Group
- New SOAs focus transformational change – early intervention and prevention
- Partnership all local public services involving private and voluntary sectors
- Better outcomes, preventing problems before they happen
