Play is absolutely essential for ensuring:

- Their intellectual & educational development
- Their social & behavioural skills
- Their creative skills





## Why Playgrounds?

Children under 15 years old represent approximately 20% of the UK population

Children play outside more than any other age group

Children learn, develop and grow through play

Children need places to play which are:

- Accessible
- Stimulating
- Safe





### Accidents in the play environment

- Playing is about 'doing', and mistakes will happen
- By 'doing' and experimenting, children improve their skills and confidence.
- Playgrounds should be challenging, both physically and mentally
- Play is about exploring these challenges and solving problems





- Play is about practising new skills in environments where risk can be managed
- Children develop differently, make unrealistic assessments or are over confident
- Injuries can be reduced, not eliminated
- Without challenge, children go elsewhere







## Injuries at play

- Approximately 185,000 annually
- Double between May & September
- Peak ages 9 10 year olds
- Mainly boys, but girls becoming increasingly involved in more risky play
- Mostly minor



## Injury causes (management)

- Poor site planning
- Incorrect layout
- Incorrect age-group selection
- Incorrect equipment design
- Incorrect installation
- Incorrect surface
- Poor inspection & maintenance





## Injury causes (user)

- Lack of supervision
- 'Misuse' of the play equipment
- Unsuitable clothing or shoes
- Weather conditions

### 3.25 Routine Visual Inspection

Inspection intended to identify obvious hazards that can result from vandalism use or weather conditions.

Typical hazards can take the form of broken parts or broken bottles.

Inspections normally undertaken on a daily/weekly basis









### 3.26 Operational Inspection

Inspection more detailed than a routine visual inspection, to check the operation and stability of the equipment

- Typical checks include an examination of wear.
- Effects of weather
- Rotting or corrosion





### Inspections normally undertaken on a monthly/quarterly basis

### 3.27 Annual Main Inspection

Inspection, at intervals not exceeding 12 months, intended to establish the overall level of safety of the equipment, foundations and surfaces.

- Effects of weather ٠
- Rotting or corrosion
- Any change in the level of safety of • the equipment as a result of repairs made, or of added or replaced components.
- Risk assessment recommended •
