Seminar Objectives

About the Seminar

For a number of years there has been a growing amount of academic research outlining the value of cemeteries and burial grounds as places where a local populations cultural history is stored. It is believed that by gaining a better understanding of the lives of the people who are buried in them, we begin to understand our sense of place and being in the areas we live in.

This appreciation of the cultural heritage has spawned a great deal of work in interpreting the architecture of such places and significant resources have been expended to preserve monuments and create educational experiences linked to burial grounds. As part of this appreciation and greater understanding, there has been a further realisation of the benefits to the natural world burial grounds can bring. Often relatively undisturbed and less intensively managed than many of our urban greenspaces, burial grounds have developed unique habitats for wildlife, many holding relics from the pre-industrial world. The world-wide decline in levels of biodiversity has further raised the importance of these spaces as potential refuges for flora and fauna we have lost in such devastating amounts elsewhere across the UK. Therefore. many councils are now utilising and enhancing these spaces, in order to reap the benefits, they bring.

Following request from member authorities to provide information on how cemeteries and closed churchyards can be utilised to support biodiversity, APSE has produced a report which offers advice, guidance and a wealth of case studies, each with their own story to tell as to how nature has been welcomed and nurtured in these spaces. Included within the report is a practical 10 step guide as to how to increase opportunities for biodiversity based on a wide range of research findings. This seminar will be of importance to any officer, elected member or stakeholder group supporting the council in increasing opportunities for biodiversity, now a local authority duty as set out in the Environment Act 2021.

Speakers will address a wide range of topics from identifying suitable sites within burial grounds for promoting biodiversity, identifying the range of biodiversity already present and how best to conserve and enhance it, managing and understanding the needs of the bereaved and biodiversity, engaging and managing volunteers and other stakeholders and recognising the wider ecosystem values of cemeteries and closed churchyards.

About the Speakers

APSE has invited senior academics, wildlife charities and local authority practitioners to speak at this event, which will be one of the most informative and interesting experiences in this field of work. Anyone who has an interest in biodiversity and preserving and enhancing it for future generations and the future of the planet will find the topics discussed of considerable interest and more importantly of practical use.
