- Graffiti **11 189** incidences removed, **113 591** metres removed (12/13)
- SLA - 48 hours for offensive graffiti  
20 days for other graffiti
- Flyposting – **291** incidences removed

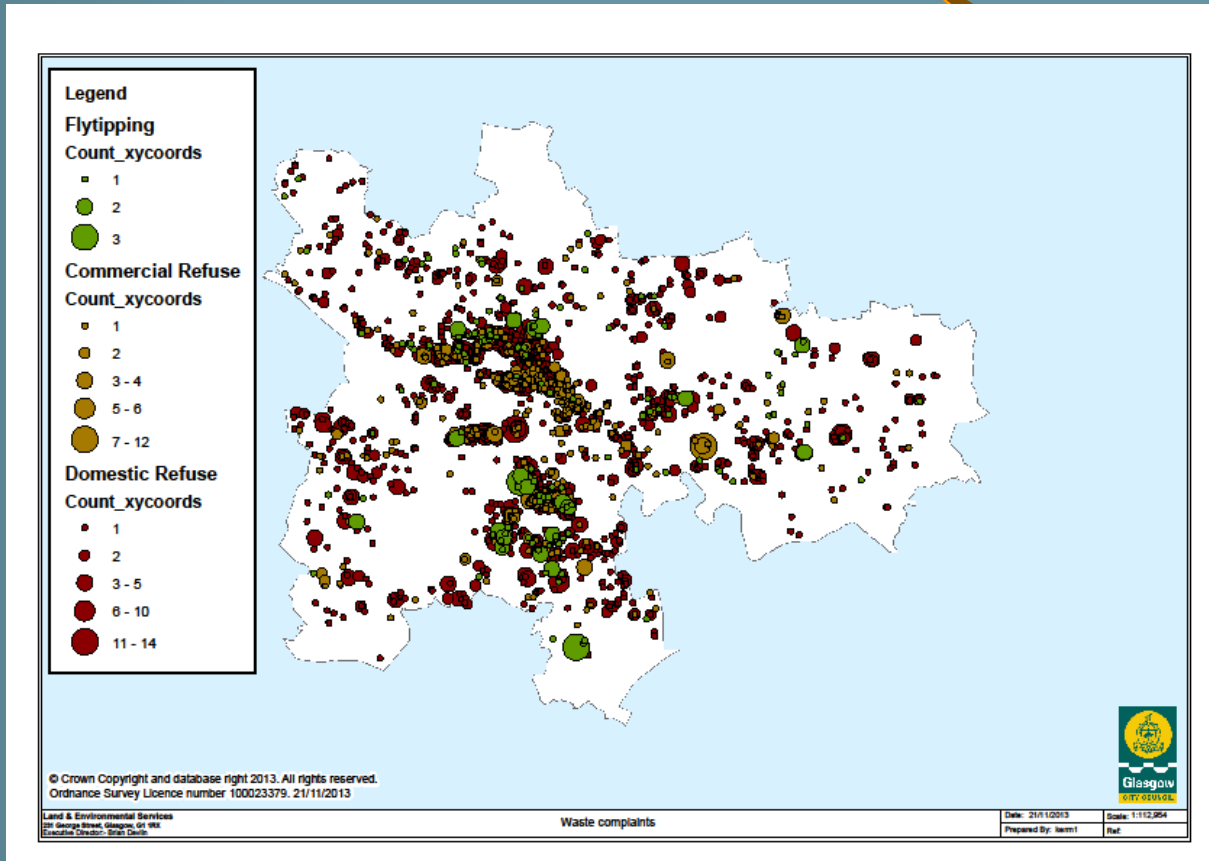
