## Minutes from this meeting

## 3. Minutes of previous meeting held on 24 February 2017

The minutes of the previous meeting were deemed to be a true and accurate record.

## 4. Matters arising

## 5. MRF Code of Practice – first results of ongoing monitoring

Naomi Ross from SEPA came to deliver a presentation on the Materials Recovery Code. The benefits of the code include: greater transparency in the marketplace, more information for contractors, it stimulates a market for sale and reprocessing of quality recyclate and improves public understanding of the way their recyclable waste is managed.

#### SEPA's use of this data includes:

- Track destinations for poor quality materials
- Identify problem waste streams and suppliers
- Improve understanding of circular economy material flows
- Improves overall understanding of Scottish waste movements
- Targets their regulatory efforts (Waste exports, duty of care, landfill tax, recycling legislation).

SEPA's approach to this started with the first site visits in May to August 2016 to assist with understanding of obligations, develop SEPA staff's understanding of sites and address any SEPA sampling logistical issues. The first formal compliance audits started from November 2016 and the second round of visits started in July 2017. An analysis tool and report were also published in July 2017.

The sampling info is currently based on 11 of the 13 sites where information is collected (excluding SITA UK Limited, Aberdeen and Biffa Waste Services Limited, Glasgow).

Clear rankings of supplier input contamination rates are not currently possible from the data returns, due to the way supplier information is reported, but there was 327,760 T processed since October 2015 from 100 "suppliers". The average national input contamination rate was 16.9% (including non-target). There has been 237,427 T recyclate extracted since October 2015.

SEPA's output sampling was broadly as expected, with all compliant except William Tracey and Wm Munro. There was offensive and hazardous waste in 8 of the 22 samples.

The key audit findings were that: recyclate was being sent to downstream facilities, there was confusion over the identification of recyclables, effective supply chain communication is key to improved quality, the export compliance risk is evident and that common compliance issues WRT misclassification and unknown final fate.

## 6. Progress of Household Recycling Charter

Charlie Devine and Adrian Bond of Zero Waste Scotland were unable to attend the meeting. They have however provided the following update:

Twenty six local authorities have now agreed to sign the Charter. A funding panel met in early September and agreed to make offers to three local authorities. The next funding panel will take place in January 2018; further details will be circulated to local authorities in due course.

Zero Waste Scotland are seeking to establish a baseline of how current services align with the code of practice. Assessment of individual council services and policies are ongoing and results will be shared with each local authority to identify those areas where simple changes could bring closer alignment to the Code of Practice and to assist planning for any more substantial changes.

#### 7. SWITCH Forum update

Charlie Devine and Adrian Bond of Zero Waste Scotland were unable to attend the meeting. They have however provided the following update:

The last meeting of the SWITCH Forum was on 5<sup>th</sup> September and considered feedback on the latest WISH guidance as well as progress on the roll out of the latest phases of the SWITCH competency framework.

The work of SWITCH and WISH was highlighted at a recent HSE Conference on Helping Great Britain work well.
