





 An interdependency is defined as an organisational interface where a climate induced risk is shared by multiple sectors, leading to increased vulnerability.



### Highways services continuity & upstream climate interdependencies











The climate resilience of highways is as strong as its weakest link.

It is important to understand how upstream climate interdependencies will impact the delivery of highways services in the short and longer-terms.

It is also key to involve stakeholders in finding solutions to mediate downstream interdependencies with other sectors.

# Building a shared understanding of climate risks across the whole system is key to...



In the shorter-term (<1 year)</li>

... better coordinated responses following extreme weather events; quicker recovery.
... creating a culture of multi-sector collaboration that can avoid unintended consequences from adapting to one climate risk in one organisation whilst creating a risk to another organisation's asset. (e.g. diversion of flood water from temporary works within the transport sector led to the collapse of a National Grid-owned tower along a riverbank).

These responses build on sufficient existing skills and capacities across the sectors and align with current regulatory and investment planning cycles.

# Building a shared understanding of climate risks across the whole system is key to...



- In the longer-term (>5years)
- ... building cross-sectoral collaborations and help organisations to recognise the challenges that climate impacts can have across multiple sectors at any one time.
- ... identifying opportunities to respond to and mitigate risks that lead to co-creating and co-funding solutions.
- ... supporting the delivery of more co-ordinated investments in climate adaptation and resilience, leading to greater efficiency / Reduce redundancy across organisations from duplicated investments in adaptation.
- ...increasing alignment of regulatory planning and investment cycles across sectors.





### The Yorkshire and Humber Climate Commission (YHCC)



- The <u>Yorkshire & Humber Climate Commission</u> is an **independent advisory body** that **brings together a wide range of people** from the public, private and third sectors to support, facilitate and enable the delivery of **ambitious climate actions** across Yorkshire and the Humber.
  - The 2024 YHCC <u>Climate Action Plan</u> sets out how Yorkshire and the Humber can respond to the climate and nature crises. Through 60 actions organised under seven themes, the plan is for everyone in our region.
    - Actions cut across the 4 themes: 1) Rapid emission reduction, 2) Climate adaptation and resilience 3) Nature restoration 4) Just transition.



### Climate Adaptation Programme for Local Authorities (CAPLA) approach



- Local Authorities are on the frontline when it comes to climate impacts. Extreme
  weather events affect everyday services, and the costs of dealing with them impact on
  budgets.
- Discussions at the YHCC Regional Policy Forum in 2022 revealed that many local authorities were unsure about the best way to develop and structure their climate adaptation plans.
- This raises the risk of maladaptation, but this can be mitigated through learning from others and by drawing on experiences and expertise from across the region.
- This peer-to-peer regional learning is at the heart of the YHCC Climate Adaptation
  Programme for Local Authorities (CAPLA). CAPLA, endorsed by the Yorkshire Leaders
  Board in 2022, is a programme of thematic sessions where local authorities can
  learn from each other (sessions themes inspired by the Local Partnership toolkit).
  These sessions help participants to pace their work.

#### **CAPLA** outcomes

YORKSHIRE & HUMBER CLIMATE COMMISSION

- By breaking the adaptation journeys into manageable steps, local authorities are building their adaptation efforts between sessions and make real progress towards becoming more climate resilient.
- CAPLA is also a **supportive space** for LAs to discuss freely their climate adaptation challenges and ways to effectively overcome them.
- Since its first year (2023), CAPLA has demonstrated that building connected capacity, expertise and leadership across local authority boundaries could accelerate climate resilience at both local and but also at regional levels.
- This programme is groundbreaking in England and offers a model that can be easily duplicated by other regions.

"The ask around developing an adaptation plan for the public health service in our local authority initially felt very daunting. Especially as much of the focus in this space seems to be around mitigation, when neither mitigation nor adaptation can be done in isolation.
