# Reform - recent progress

- Local Government (NI) Act 2014 Royal assent 12 May
- Elections held 22 May 2014 councillors for the 11 new councils elected
- Code of Conduct for councillors in force from 28 May 2014
- 10 month shadow period new councils prepare to assume full powers from 1<sup>st</sup> April 2015
- The Local Govt (Transitional, Supplementary, Incidental Provisions & Modifications) Regulations (NI) 2014 made on 2 June – these prescribe the powers & activities of new councils during shadow period
