- Current funding confirmed to July 2016
- Nicky Morgan / DfE wish to scrap UIFSM £600 million
- (Telegraph 28/09/2015) Downing Street confirmed today that Nick Clegg's flagship policy will not be axed, with an official spokesperson saying the Prime Minister was "committed" to the scheme.
- PM intervened, saying he was "very proud" of the scheme that offers free school meals to pupils aged four to seven.

- Spending review 25th November






Technology: Which of the following do you use?






Attitude to absence: Are staff absence levels at an acceptable level?
