Scottish Roads & Street Lighting advisory group Minutes 28 April 2017 Tayside Contracts Depot - Perth

#### 1. Welcome & Introduction

In the absence of Cllr Paul O'Kane, Chair of the Scottish Roads & Street Lighting advisory group, Louise Melville welcomed all to the meeting, thanking everyone for attending. Louise also thanked Tayside Contracts for their continued hospitality in hosting these meetings.

# 3. Minutes from Previous meeting held on 24 January 2017

The group agreed the previous minutes were a true and accurate record.

# 4. Matters Arising from Previous meeting held on 24 January 2017

There were no matters arising from the previous meeting.

# 5. APSE Innovation award winner: Dundee's retrofitted automated gritting journey

Ewan MacNaughton, Depute Road Maintenance Partnership Manager for Tayside Contracts provided an interesting presentation to the attendees on their innovation award. Ewan began his presentation by providing some background to the project which included:-

- Urban routes feature unnecessary double treatment
- To avoid potential human error, material is continuously spread from the start to the end of the route
- The aim was to utilise GPS vehicle tracking technology to automatically control the start/ stop spreading control and reduce the quantity of salt deployed on the network

Ewan then went on to inform the group of Dundee's winter network which includes 14 priority routes, 14 secondary routes and 12 tertiary routes, with a road network length of 570km. Before providing the group with information on Dundee's winter fleet which included 14 vehicles in total (combination of 7 x purpose built 6m³ gritters and 7 x demount gritters).

The presentation also covered the 3 main stages of the journey which covered:-

- Stage one Route optimisation
- Stage two Route navigation
- Stage three Cuthbertson/ ISL Link up

The third stage was the one which provided the biggest money save during the journey. Ewan then concluded the presentation by providing the group with a project summary which highlighted:-

- The retrofitted technology allowed Dundee to achieve financial savings from automated spreading quicker than possible with fleet renewal programme
- Retrofitted technology was prone to faults in hardware and cabling. Also issues in development of routes

- Allows desktop implementation of new routes and revisions
- Associated a 6 month implementation period with a lot of staff resource assigned to development (79 project tasks)
- Cost effective option to achieve automated spreading

Results included 30% less salt use on precautionary treatments, 7% winter revenue saving (100k per annum) and reduced carbon footprint of operation.

## 6. Creating Perfection in Traffic Management

Alistair Smith, UK Operations Manager for Hatton Traffic Management Ltd and APSE Approved Partner provided the second presentation of the meeting. Alistair provided a short presentation on traffic management and the main issues facing local authorities which included:-

- Budgets will continue to be squeezed causing continued pressures on services
- The digital interface is something which will continue to grow
- Some London Boroughs are charging utilities companies for leaving signs out after the timing of the contract
- The traffic management company should understand that when they are working on a local authority contract they are representing the Council at all times
- Local authorities can also request the scores of different traffic management accreditations, as it is not enough to say they've passed
- Opportunity to use traffic management to carry out other tasks which happen inside the cones e.g. carry out litter picking or grass cutting

Alistair then went on to update the group on a traffic light system which Hatton Traffic Management's research and development team were currently working on. Alistair confirmed he would keep the group in the loop on developments.

After Alistair's presentation he asked the group to provide information on the various levels of service available and what they would expect to be within each. This included:-

## Basic/ expected Service **Wow Service** Operative Good quality drawings Good quality communications with Van public (at all stages) e.g. use of twitter Cones Set of lights Looking for good quality equipment Plan/ drawings (e.g signage) VMS but innovation around this e.g. urban environment Digitals with self solars within them Count down of traffic to help relieve issue of light jumping

# 7. Key findings of APSE Process Benchmarking Flooding issues

Louise Melville provided the group with an update on the work of the association included the newest piece of research which was a neighbourhood services poll undertaken by Survation on behalf of APSE. Louise also provided the group with information on APSE's new Promoting Excellence You Tube programme which will be a follow up to the 2016 programme and will be concentrating on the key role local authorities have in building sustainable communities. Finally, Louise provided information on the other services provided by APSE including Energy, Solutions, Training, Performance Networks and events before finishing the presentation by highlighting the "Service awards 2017" which this year are taking place in Oxford.
