We support effective regulation to provide a high degree of protection of people and of the environment.

Approach to pesticide regulation

We recognise the importance of pesticides to food production and infrastructure protection.

Regulatory decisions should be based on scientific assessment of risk.

Any decisions to impose restrictions should be proportionate, based on the identified risk.

Commitment in the 25-year plan to put *Integrated Pest Management at the centre of our approach, combining productive agriculture with reduced environmental impacts.*

What is the Official Controls Regulation?



Regulation (EU) 2017/625 on official controls ('the OCR') - directly applicable in the UK since 14 December 2019.

Applies to food and feed law, rules on animal health and welfare, plant health and plant protection products (PPPs).

Retained in UK law under the European Union (Withdrawal) Act 2018.

Sets out framework for official controls and other activities to verify compliance with legislation.

The Official Controls (Plant Protection Products) Regulations 2020

- Domestic legislation which came into force in 2020
- Apply in Great Britain (England, Scotland, Wales)
- Businesses involved in manufacture, sale and use of PPPs
- Supplement existing pesticides legislation: enable regulators to carry out checks (official controls) throughout the supply chain to ensure compliance with:
 - > The Plant Protection Products Regulations 2011, and
 - The Plant Protection Products (Sustainable Use) Regulations 2012

What do the 2020 Regulations mean for businesses?

Each operator must notify the competent authority of:

- name;
- activities they carry out that relate to the placing on the market and use of plant protection products and components and the sustainable use of pesticides;
- premises on which those activities are carried out







Who are "Operators"?

The OCR refers to operators as:

"any person or business who has legal requirements to meet because of the placing on the market and use of plant protection products and the sustainable use of pesticides, with the exception of pesticides application equipment"







Registration Requirement

- The 2020 Regulations create a requirement for users of PPPs in a professional capacity to register.
- Manufacturers and distributors of professional PPPs were required to register by 22nd September 2021.
- Sellers of PPPs intended for amateur use are also required to register.

How to Register

1. Defra has published a simple registration form on GOV.UK.



2. To register, download the form and fill it in.



3. Save the form and email to Defra.



What does the form look like?

Professional plant protection products (PPPs) and adjuvants user registration form

You must answer all the questions in this form.

To select an answer from a list:

- 1. Select the answer cell.
- 2. Select the drop down arrow to see a list of answers to choose from.
- Select an answe

If you use a keyboard (instead of a mouse), press the 'alt' key plus the 'arrow down' key to access the list.

Your organisation name		
If you are a limited company, enter the name you registered with Companies House.		
If you are another type of organisation, such as a partnership, sole trader, or Local Authority, enter your organisation or trading name.		
Your main address		
Enter the address that is most relevant to your professional PPP activity. This might be a head office, or where you keep your records. You can add other addresses later if you have them.

Your telephone number		
Avoid giving a general organisation number if possible. It should be the contact details of someone with a good knowledge of your professional PPP activity. Enter only a number. Do not include an extension.		
Your email address		
Give the best email address to contact your business. This should be a person or department with a good knowledge of your professional PPP and adjuvant activity.

Registration Deadline

The deadline for users of PPPs in a professional capacity to register is



22nd June 2022

If you do not register by the deadline, you must do so as soon as possible.

What will be done with this information?

- Defra is receiving registrations from businesses in Scotland and Wales on behalf of the Scottish and Welsh Governments.
- This information will allow us to understand who is using PPPs around GB, where they are operating and how much they are using.
- Over time will allow us to build intelligence on issues across the supply chain and levels of compliance with PPPs legislation.

Are my data protected?

Strict data protection processes are in place at Defra to ensure data collection, storage and use complies with data protection laws.

What is the legal basis in data protection law for Defra's use of my personal data?

How will OCR be enforced for LAs?

- HSE are the regulator for the relevant PPP legislation.
- The Health and Safety (Enforcing Authority)
 Regulations 1998 allocates enforcement
 responsibilities between LAs and HSE:
 - Enforcement will fall to the respective enforcing authority for the premises.
 - For premises that come under LA responsibility,
 HSE will work with LAs to agree an approach to visits and enforcement on a case-by-case basis.
