## Implementing a Corporate Landlord Model Approach



## **Driver for Change**

- In 2022 Nottinghamshire County Council (NCC) implemented a Corporate Landlord Model approach (CLM) by creating a new team to centrally manage property safety and facilities management (PS & FM).
- The previous approach was Nominated Property Officers (NPOs). Responsibilities for properties placed with NPOs included building safety, FM and overseeing repairs. In theory, assigning this function to management colleagues, reduces expenditure and gives sites ownership of their safety. In reality, the duties were delegated, and budgets allocated for property matters were used to bolster the budgets of their core services.



#### **Team Functions**





#### Team

- The PS & FM Team consists of 60 colleagues
- In 2023 the team completed
  - 4,000 repairs
  - 500 CDM audits
  - 100 landlord consent applications
- Each month our team
  - Oversees completion of 800 servicing, inspection and risk assessments
  - Undertakes 1,600 non-technical tasks such as emergency lighting tests, flushing and fire drills





## Overcoming the Challenges



## Challenges



- Nine vacancies at launch, including at Team Leader level. Numerous early vacancies were filled by internal promotions meaning the roles they had left became vacant. There were 13 vacancies in total (22% of team)
- In July 2022 the Council's Head Office suffered a major fire. All staff were evacuated safely, and the cause of the fire was later identified as accidental electrical.



## Challenges

- Most staff transferred didn't have access to their own ICT equipment and a few didn't even have a company email.
- Operation London Bridge
- Storm Babet and Henk were devastating in Nottinghamshire, requiring a large-scale response.

## **Benefits for Individuals**

- ✓ Revised Site Manager job description. Many site staff benefited from a pay increase, which reflects the broader responsibilities of a combined FM team.
- People Plan including full competency and training matrix, with supporting property training framework
  - ✓ FM apprenticeships
  - $\checkmark$  CDM specialist will be undertaking a NEBOSH Diploma
  - School Property Manager has almost completed a level 5 ILM course
  - $\checkmark$  Team Manager finishing MBA Senior Leader Apprenticeship
- $\checkmark$  New uniform, equipment and PPE
- ✓ In 2023 the team were asked to describe the culture. They anonymously replied with phrases such as friendly, collaborative and supportive.



## **Benefits for the Organisation**

The creation of the new team has seen the following benefits for the Council.

- ✓ Improved assurance, visibility and reporting of compliance and maintenance.
- Last year Site Managers undertaking basic maintenance saved approximately £70,000.
- ✓ A holistic view of maintenance allows prioritisation of resources to critical services and buildings most in need.
- ✓ Review of cleaning resulted in £50,000 saving.
- ✓ One point of contact into Property Services
- Christmas office closures reducing running costs and carbon footprint.





## **Benefits for the Organisation**

- ✓ A huge benefit has been the flexibility and consistency of the sitebased teams.
- Previously Site Managers were allocated to one site. In the new ways of working most Site Managers still have a primary base, however now they may manage several sites and provide cover for other Site Managers as required.
- ✓ Mobile Site Managers to cover smaller sites. This new staffing model has greatly improved consistency of delivery of the service, flexibility, and adaptability.
