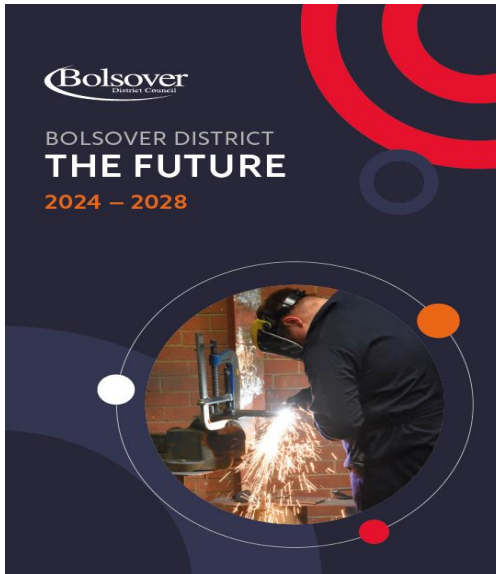

Waste Collection - Domestic Household Waste Collection undertaking 74 wheeled bin collections per year (28 Black, 26 Burgundy, 18 Green).

- 2.8million collections to 39,000 households.
- 2021 in-sourced kerbside recycling service – Now Comingled!
- Food waste – New Burden.

Street Cleansing - Principal Litter Authority removing litter, detritus & fly tipping:

- Highways and byways (445km) free from litter in line with standards (Grade <B = 4%) in line with (EPA) Code of Practice for Refuse & Litter (962tonnes).
- Fly-tipping removal (1362 approx.) occurrences annually.
- Provision and maintenance of animal waste (273) and litter bins (442).
- Education & enforcement (Joint Environmental Health & Community Rangers)
- 2022\23 APSE 'Most Improved Performer' Winner.





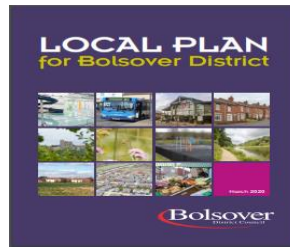
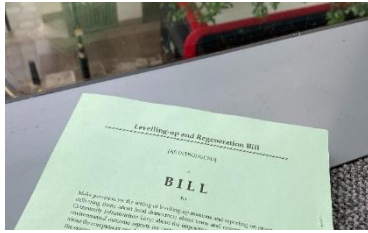
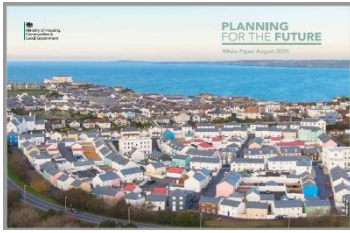
Grounds Maintenance

- Maintenance of green open space, recreation grounds, sports pitches and where requested Parish\Town Councils. (196.9Ha = 1,969,000m²).
- Weed Treatments (Quad Bikes) to 445km carriageways\footways and green open space throughout the District.

Fleet Management

- Provides and maintains road worthiness (Operator License) of the council's services fleet vehicle requirements in delivery of key frontline services.
- Procurement and maintenance of 135 (approx.) fleet vehicles, 330 (approx.) operation plant and procurement of vehicle fuel (330,000ltrs).
- Undertaking the testing of private hire\hackney carriage and Council fleet\private vehicle MOT testing (250 approx.).
- EV Fleet transition.
