solutions The Liverpool Project

Property types

- 240,000 domestic properties
- Alternative weekly collections residual/ recycling using 240L wheel bins
- 60,000 terraced properties

22,000 4ft alleyways (rear door sack collections)
38,000 9ft alleyways (Mix of wheel bin front and back door)

- A number of terraced (mainly 4fts) remain weekly due to type of collection service provided.
- Collection service provided by Liverpool Streetscene Services Limited (Wholly owned subsidiary of Liverpool City Council set up to deliver a range of Streetscene services including waste collections)



solutions Drivers for change

Alleyway conditions

Poor condition due to lack of maintenance

Complaints – waste out left out leading to smells, flies, rats

Some are adopted but many are in unknown ownership

Workforce Accidents – many RIDDOR reportable

The current service is expensive in comparison to a standard wheel bin collection service:

Recycling rates are also significantly lower from terraced properties at an average of 10 to 12%.









Progress so far...

- Alternative waste collection to 6,000 properties
- Communal bins well received by residents
- Over 1,000 Euro bins in place
- Permanent solutions :
 - Underground bin stores
 - •Semi Underground bin stores
 - Surface mounted crane lift bin
 - •1100 wheel bins
- Purchased 2 x URS Crane lift RCV's
- City centre, parks, public spaces
- LCC Planning guidance for new and refurbished Multiple occupancy sites
- APSE Solutions invited to work with the Council to develop the Framework.





So what are we trying to do.

Promote URS as an innovation to create a domino effect by demonstrating that:

- –URS brings major cost savings
- -URS brings major carbon footprint reduction
- -URS is far safer for operatives
- URS is not new or untested
- -There is a mature supply market already in existence
