The officers and councillors at Warrington Borough Council have gained a well-deserved reputation over recent years for taking an innovative approach to investment which addresses sustainability.

By highlighting local priorities including the need to make a water tight financial business case to support council services into the future, the Council has invested in assets which others may not have considered. Solar on buildings which the Council does not own, the purchase of a bank, investment in an energy company and investment in solar farms in Yorkshire are some of the examples. Having some successful schemes already under their belt, the Council is pursuing further exciting projects which are UK firsts in the public sector

Completing detailed due diligence, managing risk and project management are all fundamental to Warrington's approach. The speakers at this event will clarify the approach taken by the Council and speakers from the Council's partners will look at how they have worked in partnership to see schemes come to fruition.

Delegates will understand how barriers can be overcome whilst financial, environmental and social objectives can be achieved. They will learn how an innovative local authority can make things happen and how the principal of their approach can be transferred to other councils. Officers and councillors with responsibility for financial management, investments, sustainability and energy, regeneration and organisational development will benefit from attending this event.

A Public Sector Social Impact Fund is another project that Warrington is working on, a scheme that will bring benefits for all those councils who decide to invest in what will be a sector wide approach to investments.
